

Towards a Communist Armed Conflict Indigenous Settlement Framework: Revisiting Vietnam, Singapore, and Taiwan Experience

Abstract. Armed conflicts between governments and indigenous inhabitants in Singapore, Taiwan, and Vietnam have deep roots in historical tensions and the marginalization of minority groups. This qualitative study explores these factors and evaluates government strategies for conflict resolution, focusing on disparities in settlement, education, employment, and community engagement. Government actions such as military operations, peacebuilding, and comprehensive programs were analyzed. Singapore's strategies, including community engagement and socio-economic development, fostered stability and inclusivity. Taiwan's reconciliation efforts, including apologies and democratization, reduced conflict and promoted indigenous rights. Vietnam's initiatives for ethnic minority development underscored its commitment to peace through inclusive approaches. Historical contexts in these countries, marked by ethnic tensions, colonial legacies, and ideological divisions, shaped significant violence and social divisions, necessitating robust security measures and reconciliation efforts. Lessons learned emphasize diplomacy, international cooperation, and socio-economic integration for lasting peace. Governments must prioritize dialogue, inclusive policies, and sustainable development supported by international partnerships. Effective conflict resolution integrates socioeconomic development and reconciliation efforts, crucial for building resilient societies and fostering peace among Indigenous populations.

1.0 Introduction

Armed conflicts between governments and indigenous inhabitants in countries like Singapore, Taiwan, and Vietnam stem from historical tensions and the marginalization of minority groups. In Singapore, historical narratives and educational curricula have marginalized the Malay indigenous community, reflecting deep-seated ethnic hostilities. Despite some progress, Malay contributions remain overshadowed by dominant ethnic Chinese narratives. Singapore's strategies for fostering social cohesion and national identity include community engagement, military reforms, and national service to build an inclusive society (Allen & Louis, 1993; Sim, 2018).

In Taiwan, indigenous peoples, comprising about 2.38% of the population, face economic and social inequalities, cultural assimilation, and language extinction due to historical government policies. Efforts for political self-determination, cultural revival, and economic development are ongoing, supported by initiatives like the Austronesian Cultural Festival (Myers & Lin, 2007; Tsai, 2016). Taiwan's reconciliation efforts, including formal

apologies and a transition to democracy, have reduced armed conflict by promoting indigenous rights and facilitating political reconciliation (Myers & Lin, 2007).

Vietnam's Central Highlands, home to the Montagnards, have seen conflict due to state-sponsored colonization and ethnic Vietnamese settlement. Government policies focus on economic development and integration, but ethnic tensions persist. Vietnam's recent foreign policy emphasizes peacebuilding and conflict prevention, enhancing its international peacekeeping role (Nguyen, 2015; Turse, 2013).

These experiences underscore the importance of inclusive approaches, socio-economic development, and cultural recognition in conflict resolution. Effective strategies integrate reconciliation efforts and comprehensive government programs, promoting long-term peace and stability (Bayly & Harper, 2005; Harbom et al., 2006). Collectively, the experiences of Singapore, Taiwan, and Vietnam offer insights into mitigating armed conflicts and fostering harmonious relationships, emphasizing inclusivity and participation as crucial elements in sustainable peacebuilding (Maynard, 2019; Petterson & Wallensteen, 2015).

2.0 Methodology

This study adopted a qualitative and descriptive method to determine the factors resulting in armed conflict between the indigenous inhabitants and the governments in selected Asian countries such as Singapore, Taiwan, and Vietnam, as well as the best practices of the government. The same method is adopted to determine government actions such as military operations, negotiations, peacebuilding, and conflict resolution among conflicting parties. This approach involved detailed case studies, interviews, and document analysis to gather comprehensive data on these conflicts' historical, social, and political contexts.

Data gathering was done by searching reliable data information such as documentaries and the likes posted by various institutions and individuals who have documented the armed conflict and indigenous settlements in the countries under study. The online research focused on reliable documentaries and institutional online publications. This modality is believed to be a more reliable and economical way of gathering necessary data-information about armed conflict and indigenous settlement in the countries under study.

3.0 Results and Discussion

3.1. Extents of Armed Conflict

Revisiting Singapore Conflict

The fall of Singapore to the Japanese in 1942 marked a tragic period with massive loss of life and harsh occupation (Allen et al., 1993). The segregated colonial society exacerbated tensions that continued to haunt the nation post-World War II (Bayly et al., 2005). However, the recognition of these issues by Singapore's early leaders, especially in addressing racial and religious fault lines, laid the foundation for a more cohesive, meritocratic, multiracial society. The painful separation from Malaysia underscored the necessity of equality and unity for Singapore's progress (Lee, 2000).

Revisiting Taiwan Conflict

According to Myers and Lin (2007), the White Terror in Taiwan represents a dark era of political repression under martial law, with intellectuals and dissenters suffering greatly. The long-lasting impact of this period eventually led to significant democratization efforts and public acknowledgment of past injustices (Lee, 1995). Taiwan's journey from repression to reconciliation highlights the importance of transparency, accountability, and the commitment to human rights in forging a resilient democracy (Ma, 2008).

Revisiting Vietnam Conflict

The Vietnam Conflict, marked by extensive civilian casualties, underscores the brutality of war and the complexities of guerrilla warfare (Lewy, 1978). The actions of North Vietnamese, South Vietnamese, and American forces resulted in profound suffering for countless civilians (Rummel, 1997). The conflict's legacy, including atrocities like the My Lai Massacre and the indiscriminate nature of bombings, serves as a stark reminder of the human cost of war and the imperative for ethical conduct and accountability in military operations (Greiner, 2009; Turse, 2013). According to the Information Bureau of the Provisional Revolutionary Government of South Vietnam (PRG), a shadow government formed by North Vietnam in 1969, between April 1968 and the end of 1970,

American ground troops killed about 6,500 civilians during twenty-one operations either on their own or alongside their allies. Nick Turse, in his 2013 book Kill Anything that Moves, argues that a relentless drive toward higher body counts, a widespread use of free-fire zones, rules of engagement where civilians who ran from soldiers or helicopters could be viewed as VC, and a widespread disdain for Vietnamese civilians led to massive civilian casualties and endemic war crimes inflicted by U.S. troops. One example cited by Turse is Operation Speedy Express, an operation by the 9th Infantry Division, which was described by John Paul Vann as, in effect, "many My Lais". The war's impact on Vietnamese society continues to be felt, influencing both historical memory and contemporary geopolitics (Vietnam War Crimes Working Group, 1971).

3.2 Factors Resulting to Armed Conflict

Revisiting Singapore

The exclusionary history of Singapore's independence struggle reveals deep-seated ethnic tensions that continue to shape societal narratives today. The journey toward inclusivity in historical narratives reflects a broader effort to acknowledge and rectify past injustices, fostering a more cohesive national identity. As Sim (2018) argues, Singapore's evolving historiography is a testament to the ongoing dialogue and reconciliation processes to heal historical wounds and promote social cohesion.

Revisiting Taiwan

Taiwan's historical conflicts, rooted in colonialism and land disputes, have left lasting scars on indigenous communities. However, efforts towards cultural revival and political self-determination signal a resilient pursuit of rights and recognition. Tsai's (2016) analysis underscores the significance of indigenous movements in Taiwan, highlighting the ongoing struggle for autonomy and preserving cultural heritage amid broader socio-political changes.

Revisiting Vietnam

Vietnam's tumultuous history, marked by foreign occupation and internal strife, underscores the profound human costs of war. The enduring impact on Highlanders highlights the complex legacies of conflict and the ongoing struggles for autonomy and justice. Nguyen (2015) provides valuable insights into the challenges faced by Vietnam's Highlanders, emphasizing the need for continued efforts to address historical injustices and support marginalized communities in their quest for recognition and rights.

3.3. Government Action in Combatting Armed Conflicts

Singavore

Singapore's approach to combating armed conflict and insurgency has been multifaceted, combining security measures with social policies to foster unity and harmony. The Maintenance of Religious Harmony Act (MHRA) and the Ethnic Integration Policy (EIP) are examples of legislative initiatives designed to promote social cohesion (Tan, 2017). By addressing both security threats and societal divisions, Singapore has demonstrated a comprehensive strategy for maintaining peace and stability. Moreover, Singapore's governance model, characterized by pragmatic policies and proactive community engagement, has contributed significantly to its success in managing internal security challenges (Heng, 2019). Taiwan

The Martial Law and Suppression period reflects a period of strict control and suppression of dissenting voices (Yeh, 2017). However, Taiwan has also evolved in its governance approach, transitioning towards a more democratic and rights-based framework in recent decades. The government's efforts to address historical injustices and promote indigenous rights signify a broader commitment to inclusivity and social justice (Chang, 2015). Taiwan's journey in navigating internal security challenges underscores the importance of balancing security imperatives with respect for human rights and democratic principles.

Vietnam

Moreover, the nation's emphasis on confidence-building measures, Track II diplomacy, and economic cooperation underscores its holistic and multi-faceted approach to conflict resolution, offering valuable lessons for other countries grappling with similar challenges (Chang, 2015; Tan, 2017; MCCY, 2019).

Lessons Learn from Taiwan Experience

Vietnam's journey provides valuable insights into the complexities of post-conflict recovery and the importance of sustainable peace-building efforts rooted in inclusivity, reconciliation, and socio-economic development.

A holistic and multi-faceted approach combines military, political, economic, and social measures to address grievances and provide alternative pathways for those susceptible to radicalization, focusing on more than just a military response. Long-term commitment and adaptability involve continual policy reviews and improvements to dynamically address armed conflicts and insurgencies, offering insights for other nations facing similar challenges. Economic cooperation and development programs aim to tackle root causes of conflict, such as poverty, inequality, and social exclusion, while promoting economic integration, trade, and investment to build interdependence and shared interests among nations. Strictly implementing the rule of law and adherence to international norms promotes peaceful dispute resolution through legal mechanisms. Strong governance and political will are essential for maintaining law and order and protecting national security. Lastly, multilateralism and international cooperation through organizations like the United Nations, ASEAN, and APEC foster dialogue, build relationships and seek consensus on peace and security issues.

The recommended action plan for Singapore's indigenous settlement encompasses several crucial components. Rehabilitation and Reintegration programs are vital, focusing on providing education, vocational training, and employment opportunities for former insurgents to break the cycle of conflict. Community Engagement and Social Integration are equally important, fostering dialogue, addressing socio-economic disparities, and countering radicalization efforts. Confidence-building measures should be implemented to reduce tensions and build trust among conflicting parties, alongside active Diplomacy and Dialogues involving stakeholders from various sectors. A Holistic and multi-faceted approach is essential, combining military, political, economic, and social measures to address root causes. Long-term commitment and adaptability are emphasized for continuous improvement, along with a commitment to Economic Cooperation and Development, Rule of Law, and International Norms. Multilateralism and international cooperation are also advocated and supported by strong governance and political will to confront challenges effectively. These strategies draw from Singapore's experiences but emphasize the need for tailored approaches based on specific contexts.

Action Plan for Taiwan

This study highlights several core activities and specific programs to address armed conflict and promote peace in various regions. Democratization and political reforms, such as lifting martial law, establishing multi-party elections, and expanding political freedoms, aim to address historical grievances, promote political participation, and reduce the appeal of radical ideologies. Reconciliation and reintegration efforts focus on fostering national unity and healing historical divisions by pursuing policies that reach out to former dissidents and exiled individuals, encouraging their return to Taiwan to participate in political processes. Truth and reconciliation efforts have shifted from suppression and martial law to socio-economic development, democratization, political reforms, and reconciliation, with objectives to uncover and document past abuses, promote understanding, and contribute to social healing. Economic development policies supporting industrialization, export-oriented growth, and job creation address the root causes of conflict by providing opportunities for the population and reducing support for radical ideologies. Strengthening economic capabilities and diversification aims to reduce vulnerability to economic coercion by investing in defense, technology, and human capital. Public awareness and resilience programs educate the public about potential threats and promote community resilience to foster a sense of national unity and cohesion. Vigilance and preparedness involve maintaining a modern and well-equipped military, investing in intelligence capabilities, and conducting regular exercises to enhance readiness against potential security threats. Deterrence and defense strategies maintain stability and security through credible military capabilities while developing asymmetric strategies to counterbalance resource and size disadvantages. Cybersecurity and information warfare measures counter the increasing prevalence of cyber threats and disinformation campaigns by strengthening cybersecurity, enhancing intelligence capabilities, and promoting public education. Continuous adaptation and innovation through investment in research and development foster a culture of innovation to dynamically address armed conflict and insurgencies and leverage technology for enhanced security. Lastly, diplomatic and international engagement involves building alliances, seeking international recognition, and cooperating with like-minded countries on security issues to strengthen the national security position through diplomatic leverage.

The action plan proposed addresses the root causes of conflict in Taiwan while providing opportunities and reducing support for radical ideologies. Democratization and Political Reforms, such as multi-party elections and expanded political freedoms, aim to address historical grievances and reduce radical appeal. Truth and Reconciliation Efforts uncover past injustices, promoting understanding and reconciliation. Economic Development initiatives provide opportunities, while Economic strength and diversification bolster overall security. Public awareness, Vigilance, and preparedness ensure stability, while Deterrence and Defense strategies maintain security. Cybersecurity measures address modern threats, and Continuous adaptation and innovation enhance security capabilities. Diplomatic and international engagement strengthen Taiwan's security position through alliances and cooperation. Each strategy is tailored to Taiwan's unique challenges and dynamics, emphasizing a comprehensive conflict resolution and security approach.

Reconciliation Processes acknowledge past atrocities, promoting healing and accountability. A Comprehensive Peace Plan involves the peace establishment's political, military, and economic components. International Support and Cooperation aid in post-conflict recovery through economic and diplomatic support. These strategies, learned from Vietnam's experiences, provide insights for other countries facing similar challenges.

4.0 Conclusion

In conclusion, the analysis of armed conflicts in Singapore, Taiwan, and Vietnam highlights the profound impacts of historical events, societal tensions, and government actions on the extent and nature of violence. The conflicts in these regions have resulted in significant casualties, human rights violations, and enduring social divisions, underscoring the critical need for comprehensive strategies and proactive measures to address armed conflicts.

The prolonged martial law period and suppression of dissent highlight challenges in political reconciliation and human rights protections. Efforts toward reconciliation and democratization have been pivotal in promoting stability and national identity. Vietnam's conflicts have been shaped by ideological divisions, colonial influences, and international dynamics, resulting in immense civilian casualties and societal upheaval. Government actions have ranged from military operations to socio-economic development programs and international cooperation initiatives to address conflict-related challenges.

Strengthening governance, upholding human rights, promoting truth and reconciliation, and fostering grassroots participation are essential for long-term peace and stability in conflict-affected regions. Governments must prioritize dialogue, inclusive policies, and conflict resolution mechanisms while addressing root causes, promoting accountability, and ensuring sustainable development for lasting peace and prosperity. International support, partnerships, and continuous learning are crucial in navigating complex conflict dynamics and building resilient societies.

These insights inform the current study by emphasizing the critical need for comprehensive strategies that integrate diplomacy, mediation, and international cooperation alongside efforts in political reconciliation, economic development, and social integration. The lessons learned stress the importance of strengthening governance, upholding human rights, promoting truth and reconciliation processes, and fostering grassroots participation to achieve long-term peace and stability in conflict-affected regions. Moreover, the findings highlight governments' need to prioritize inclusive policies, effective conflict resolution mechanisms, and sustainable development initiatives while addressing root causes and promoting accountability. Finally, the study underscores the significance of international support, partnerships, and continuous learning in navigating the complexities of armed conflict and building resilient societies capable of enduring peace and prosperity.
